The Grays Harbor Community Foundation employs a conservative investment policy that has over the years been very successful producing returns higher than benchmarks, while also protecting the assets. Our Finance Committee, made up of Board members with significant financial experience, advise the Board on investment strategy and policy. We work with two investment advisors to manage our assets in compliance with our investment policy that is reviewed quarterly, as is the performance of the two advisors.

# Your Gifts at Work

## How Community Foundation Awards Are Granted

**Designated Funds:** A designated fund is often the result of an estate where the donor has specified a nonprofit, or several nonprofits, to receive the benefit of the gift. A designated fund may be set up to provide support for an established nonprofit to receive specific distributions for a specific purpose or could be an unrestricted gift to the nonprofit.

**Donor Advised Funds:** A donor advised fund is where the donor is involved in determining the distributions of the funds at some level. The donor may suggest distributions to a nonprofit at any time, for any purpose.

**Scholarship Funds:** A scholarship fund may be established by virtually anyone; individual, nonprofit, or business, to commemorate an individual, to support a particular school or a particular field of study.

The donor determines the criteria for the student to qualify for the scholarship, and may even be involved in the selection process. The Community Foundation then administers the scholarship to minimize the effort required by donors.

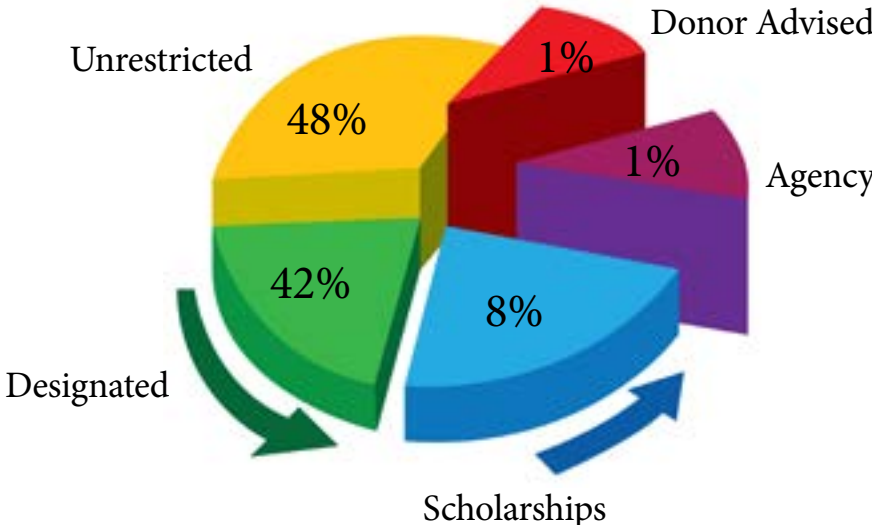

**Agency Funds:** An agency fund is for a nonprofit to set up or set aside funds for the future. If the nonprofit has funds that are specified for a capital improvement project, for example, and that project is to begin three years in the future, they may set aside and protect funds to grow and be added to as fundraising develops the resources. They may also set aside funds for future operations.

# Community Building Grants

## A Place to Belong: Montesano Community Center

The Foundation awarded a grant to the Montesano Community Center to purchase dining and kitchen equipment for their new Senior Center in 2016. They average around 40 meals served per day and beyond providing nutrition, they are giving Montesano seniors a place to gather and enjoy their day with friends.

## Feeding Our Community South Beach Christian Outreach

South Beach Christian Outreach was organized in 1997 to assist people from Ocosta to Tokeland in meeting basic emergency needs. The churches of Westport and Grayland collaborated together to best assist the poorest among us. They provide food vouchers, energy assistance and meet other requests for basic needs. In 2016, the Foundation awarded them a grant for emergency food vouchers.

Deanna Bell, President of the Board of Directors commented: *“WE WOULD LIKE TO BE ABLE TO REALLY GIVE OUR CLIENTS A HAND UP, NOT JUST A HAND OUT. WE ARE LOOKING TO HAVE A PLACE WHERE THEY CAN COME AND FEEL COMFORTABLE TALKING ABOUT THEMSELVES WITHOUT FEELING LIKE THEY AREN'T BEING RESPECTED.”*



# Learning to Play Nice: McCleary Playground

McCleary School District recently received a grant for a new playground structure. With this new structure, the school district hopes it would create a more peaceful school environment, specifically, a more peaceful and safe playground.

*“OUR HOPE IS TO HAVE A BETTER-ORGANIZED PLAYGROUND THAT INVOLVES CHILDREN IN A VARIETY OF ACTIVITIES THAT WILL REDUCE INJURY AND CONFLICTS WHILE MOTIVATING THEM TO BE PHYSICALLY ACTIVE. WE WANT TO USE OUR PLAYGROUND AS A PREVENTIVE POSITIVE BEHAVIOR SUPPORT PROGRAM. THIS NEW PLAYGROUND AND IDEALS WILL INSTILL RESPONSIBILITY AND CONFLICT RESOLUTION SKILLS THAT TRANSCEND FROM THE PLAYGROUND TO THE CLASSROOM, THE HOME AND THE COMMUNITY. STUDENTS WILL LEARN TO PLAY COOPERATIVELY AND COMPASSIONATELY ON THE NEW PLAYGROUND, WHICH WILL EMPOWER THE CHILDREN AND TEACH THEM TO WORK COOPERATIVELY IN THE CLASSROOM AS WELL. IT ALSO HELPS TO DEVELOP MOTOR SKILLS, SOCIAL SKILLS AND COGNITIVE SKILLS THROUGH THE VARIOUS GAMES AND ACTIVITIES. WE BELIEVE THROUGH THIS NEW PLAY AREA AND IDEOLOGY WILL SHOW A DECREASE IN BULLYING, AN INCREASE IN CHILDREN’S PHYSICAL ACTIVITY LEVELS AS WELL AS, FEWER PLAYGROUND INJURIES.”*

# Project Hope: Gravity Grays Harbor

The Foundation awarded a grant to Gravity Grays Harbor’s “Project Hope” in 2016. Gravity lays a foundational “Pathway to Possibilities” for young people who have previously been confounded by traditional educational approaches. By persistently bonding with each student, the staff tailors their individual educational plans and devises appropriate teaching strategies for them while simultaneously working to resolve their survival issues.

Ed Liedtke, Professional Educator for Gravity commented: *“STUDENTS IN THE GRAVITY PROGRAM ARE TAUGHT AND MODELED SELF-MOTIVATION, RESPONSIBILITY, SELF-ADVOCACY, APPROPRIATE DECISION MAKING AND GOOD PHYSICAL AND MENTAL HEALTH PRACTICES. STEPS TO ACCESSING LOCAL MENTORING AND COMMUNITY SERVICES, TO JOB SEARCH SKILLS, AND PARTICULARLY TOWARDS LIFE PLANNING ARE LIKEWISE MAJOR PROGRAM GOALS. THIS HOSTILIC APPROACH IS RESULTING IN HIGHLY SUCCESSFUL OUTCOMES. GED’S ARE BEING COMPLETED, JOBS ARE BEING SECURED, AND COLLEGE AND TRADE SCHOOL TRANSITIONS ARE BEING MADE.*

*PROJECT HOPE PROVIDES STUDENTS WITH EMERGENCY AND BASIC ITEMS, ALONG WITH WORK READINESS ESSENTIALS AND MOTIVATIONAL INCENTIVES NECESSARY TO SPRINGBOARD THEM INTO INDEPENDENCE.”*



# Endowment Grant

In 2016, the Grays Harbor Community Foundation awarded a \$50,000 endowment grant to the 7th Street Theatre Association. The purpose of an endowment grant is to build for the future by setting aside funds that will be invested and earn interest while the principal remains untouched.

The Foundation considered several organizations that had received funding in the recent past and were impressed by 7th Street Theatre's plan to build upon an endowment grant for the betterment and longevity of their organization.

Ray Kahler, President of the 7th Street Theatre Board of Directors, commented: "Having an endowment fund at the Foundation allows us to have a trusted community organization oversee the funds, while our primary focus remains on providing an affordable family entertainment venue for our citizens to enjoy. Knowing we have a revenue stream we can access and build upon is very exciting for us."



# Capacity Building

In addition to recognizing the long term needs of our nonprofits through our Endowment Grant Program, the Foundation also committed to helping nonprofit organizations thrive and strengthen their internal operations in 2016 through our Capacity Building Grants Program.

The goal of our Capacity Building Grants Program was to strengthen management infrastructure and governance in organizations. Capacity Building is a term that encompasses "actions that improve nonprofit effectiveness," in terms of organizational and financial stability, program quality and growth.

By offering Capacity Building grants, we recognized organizations need the opportunity to build management systems as well as programs. By helping improve organization's systems and operations, we saw it as an opportunity to strengthen their ability to serve our residents.

We awarded ten \$5,000 grants to local nonprofits. One of our recipients, The YMCA of Grays Harbor, was awarded funds to conduct a master plan for Camp Bishop. Last year through their collaborations with school districts for their Outdoor Education Program, they served 178 youth in our community and over 825 youth through their resident and summer camps.

The goal of the master plan was to have a clear vision for the future of the camp. The YMCA worked in late September 2016 with OCBA Landscape Architects and camp stakeholders to develop the plan to fulfill their operational needs, and illustrate their hopes and plans for the future of YMCA Camp Bishop.

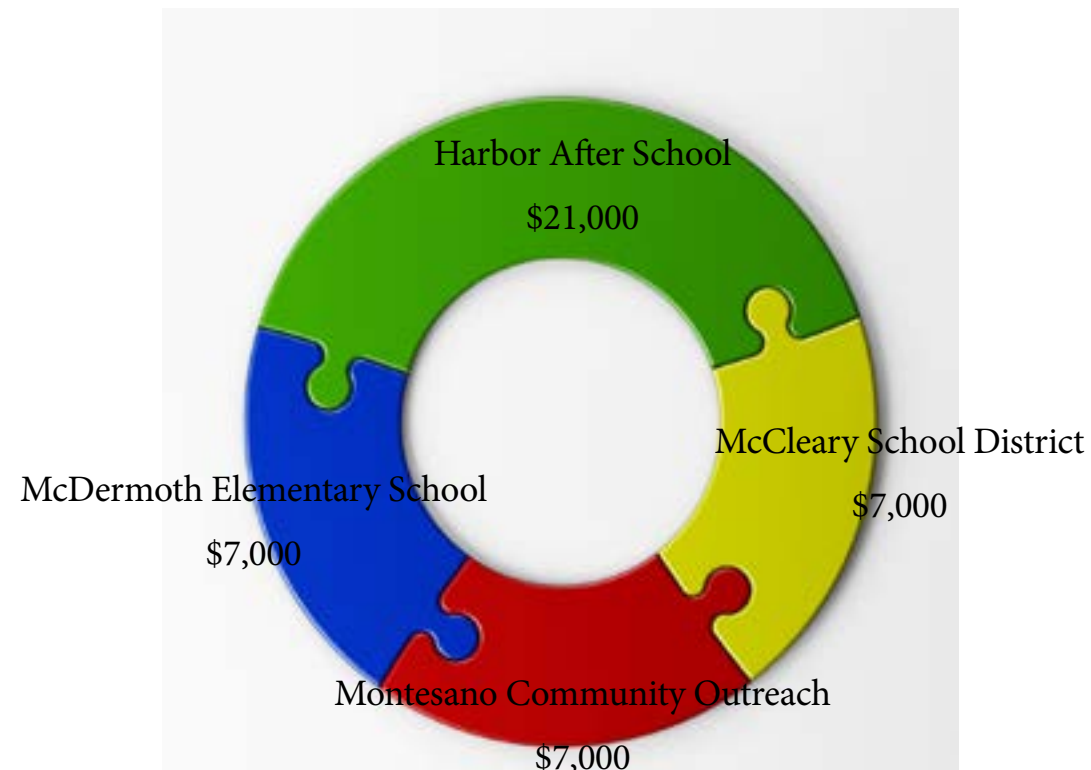


# Annual Education Grants & After School Funding

The Community Foundation also offers annual grants to school districts and Grays Harbor College. In 2017, the Foundation plans to award over \$200,000 to our schools through a combination of our Annual Education Grants and After School Grants Programs.

Our After School Grants Program was designed to provide schools with additional funds to strengthen their existing programs. We typically award around \$45,000 total on an annual basis to 4-7 after school programs.

# Cultural Tours

Grays Harbor second and third graders attended The Bishop Center's productions of both James and the Giant Peach and Mary Poppins.

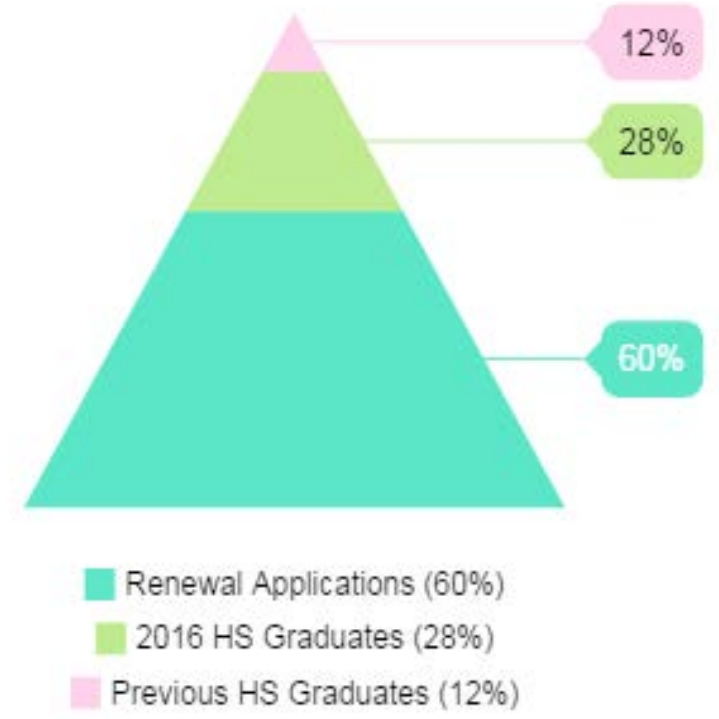

# Donor Spotlight: Dick & Patricia Warren

In 2016, the Grays Harbor Community Foundation received a significant contribution from the estate of Dick and Patricia Warren.

Dick and Patricia were longtime residents of Hoquiam. Dick passed away in 2013 after a short battle with cancer and Patricia followed in 2015. They were quoted by the Seattle PI after winning a large sum of money in the Washington State Lottery, “For us, we put the emphasis on how to give the money away. We want to donate it ethically and effectively. We think we’ve done very well at that.”

Dick served on the Grays Harbor Community Foundation Board of Directors for many years and was always passionate about philanthropy.

The Warren’s requested that a portion of the funds gifted to the Foundation create an endowment fund to benefit the Hoquiam and Copalis Food Banks.



# Donor Spotlight: Keith & Nancy Rattie

Growing up in Grays Harbor, most of us have had dreams of taking our small town roots and seeing how they grow in the outside world. Keith Rattie, an Aberdeen High School Class of 1972 graduate and Class Salutatorian did just that. Still having ties to Grays Harbor, Keith was referred to the Grays Harbor Community Foundation in an effort to give back to the high school that encouraged his early success. Keith and his wife Nancy recently established the “Keith and Nancy Rattie Scholarship” for Aberdeen High School graduates majoring in the STEM field. This is a very generous scholarship that is renewable for 3 additional years.

A self-proclaimed Aberdeen boy who “didn’t have a clue” about what he wanted to do, Keith went on to graduate from the University of Washington with a Bachelor of Science in Electrical Engineering (Magna Cum Laude at that) and then to St. Mary’s College for his MBA thanks in large part to a program called “Dollars for Scholars.” This program at Aberdeen High School in the 1970’s provided him the important financial support he needed to attend college to pursue his dreams and jump started what would be many years as a businessman at the pinnacle of success in the energy field.

Keith began his career at Chevron Corporation serving in various engineering, operations and project management roles, including General Manager of the company’s International Natural Gas division. From there, Keith served as Senior Vice President of The Coastal Corporation and then Chairman, President and CEO of Questar Corporation. Now retired, Keith is an active participant in public discourse on energy policy, including multiple appearances before US Congress representing the industry in hearings on energy policy.
