

Percentage of Assets by Fund Type



Your Dollars at Work

Established in 1994, the Grays Harbor Community Foundation has awarded over \$16M in grants and scholarships since its inception. Here is how our donors gave back to our community in 2017:

Designated Funds: \$854,127

A designated fund is often the result of an estate where the donor has specified a nonprofit, or several nonprofits, to receive the benefit of the gift. A designated fund may be set up to provide support for an established nonprofit to receive specific distributions for a specific purpose or could be an unrestricted gift to the nonprofit.

Donor Advised Funds: \$268,116

A donor advised fund is where the donor is involved in determining the distributions of the funds at some level. The donor may suggest distributions to a nonprofit at any time, for any purpose.

Agency Funds: \$30,123

An agency fund is for a nonprofit to set up or set aside funds for the future. They may also set aside funds for future operations.

Unrestricted Funds: \$1,045,993

Unrestricted funds are donations the nonprofit may use for any purpose. Unrestricted funds usually go toward the operating expenses of the organization or to a particular project that the nonprofit picks.

Scholarship Funds: \$234,920

A scholarship fund may be established by virtually anyone; individual, nonprofit, or business, to commemorate an individual, to support a particular school, a particular field of study.

The donor determines the criteria for the student to qualify for the scholarship. The Community Foundation then administers the scholarship to minimize the effort required by donors.



Giving Priorities

- 1. Establish quality education and learning opportunities for all ages.
- 2. Promote health and wellness.
- 3. Provide broad access to arts, culture and history.
- 4. Help meet the basic needs of our residents.

Through our Grants Program last year, we awarded funds to our local non profits as well as other charitable organizations.

In accordance with our Giving Priorities, we receive applications from community partners twice annually for programs and projects that are to the benefit of our community. We also offer a quarterly Small Grant cycle for projects that are \$5,000 and under.

We are also proud to support our local school districts and college through our Annual Education and After School Grant Programs.

YMCA of Grays Harbor

Creating a Camp Experience for all Grays Harbor Youth



Many of us that grew up in Grays Harbor have fond memories of summers spent at Camp Bishop during our youth. During our Community Building Grants cycle in 2017, the YMCA of Grays Harbor was awarded a grant for a kitchen remodel at Camp Bishop. Their previous kitchen was inefficient in its design and safety standards, limiting the number of youth they could serve.

Franzine Potts, Executive Director of the YMCA of Grays Harbor said of the project:

"The Grays Harbor Community Foundation was instrumental in the success of the camp kitchen remodel project. This award of this grant allowed us to make necessary changes which increased our capacity to better serve the youth in our community.

In 2016, summer resident camp served 419 youth. Due to increased efficiency and capacity we were able to serve 512 youth in 2017. Of the 512 youth served, 218 of these youth attend on some sort of scholarship assistance, showing the need in our community for accessibility.

We also showed an increase in our Fall Outdoor Education rental capacity from 120 to nearly 180 students."

Beyond Survival Healing Our Community



Beyond Survival strives to support, educate & empower all people impacted by Sexual Abuse in Grays Harbor. Last year, the Foundation awarded a grant for their new Healing House project. Maddie Graves-Wilson said of the grant:

"Healing House is an idea Beyond Survival staff came up with about a year ago when we realized we were out growing our space and our current space was not fulfilling the needs of our clients. Upon speaking with several survivors and parents of child survivors, it was brought to our attention our clients did not want to receive services in an office building.

Healing House has provided a safe comfortable environment for clients to give statements to law enforcement. Healing House is not only a supportive environment for clients but for our community as well.

The Foundation's support of this project made it possible for Beyond Survival to provide a space set aside for healing within our community and for that we are so grateful. Thank you."

Twin Harbors Skills Center

Medical Assistant Program in Collaboration with Grays Harbor College

The Twin Harbors Skills Center is a consortium of 11 high schools in 10 districts providing career and technical education to high school students interested in employment after high school and/or preparation for entering college or apprenticeship.

The Medical Assistant Program in collaboration with Grays Harbor College currently has 20 students enrolled. Their Director, Lynn Green, said of the grant that was awarded for their program last year:

"Our original goal for this program was to hire qualified staff, complete planning the overall curriculum and program components, recruit 20 students and begin in the fall quarter of the 2017-18 school year.

We implemented the program during the Fall of 2017 with 22 students, all of whom completed the first few courses. During the current winter quarter, 20 students remain enrolled and committed to completing the program.

The skills center students were provided textbook and Sim chart materials funded by the GHCF grant. Nearly all of these students qualify for free and/or reduced lunch and needed this support to be able to participate in the program."

I see a more mature approach to accepting others and their unique and sometimes opposing viewpoints and opinions. The workshops we attended at the Festival highlight being confident in their individual uniqueness while working as a team toward a shared goal.

We continue to enjoy a solid membership core and add to our numbers each year. We are committed to including all who desire to gain more knowledge and personal growth through theatre involvement. Thank you for offering us a broader view of the world on and off stage."

Investing In Our Youth

In 2016, the Grays Harbor Community Foundation launched our "Great Beginnings of Grays Harbor" project to support quality early learning opportunities for our youngest residents.

Thanks to the YMCA of Grays Harbor and North Beach School District, we helped launch a new Preschool and Afterschool Enrichment Care location at Pacific Beach Elementary this past year. This is the first all day Early Achievers level preschool in Grays Harbor and we are proud of our partners for making this program a reality for students.

The preschool has a licensed capacity of 20 preschoolers. Advances in science and research have proven the important impact preschool programs can have on children's learning. Unfortunately, too many children still do not have access to these programs causing huge educational gaps to exist for some children when starting kindergarten. The addition of the new preschool site at Pacific Beach Elementary expands access to high-quality preschool and help narrow achievement gaps.



Scholarship Program

In 2000, the Foundation awarded 2 scholarships for \$1,000 each. The scholarship program has since grown dramatically, In 2017, the Foundation awarded 334 scholarships for over \$708,000 to students that graduated from a Grays Harbor high school or reside in Grays Harbor County. Our scholarships are renewable for an additional 3 years to any undergraduate or vocational program of the student's choice.



Donor Spotlight Jeannette Effie DeYoung Mowe Scholarship



Our scholarship program is made possible by people like the Mowe Family. In 2016, the Mowe Family set up a scholarship fund to honor their late mother Jeannette Effie DeYoung Mowe. In creating this scholarship, it was the family's sincere hope that the recipient of the scholarship would prove that a hardscrabble kid from a small town in Grays Harbor County is just as smart as anybody else. Maybe smarter.

This scholarship fund is a collaborative family effort with several siblings contributing to the fund each year to keep their mother's wonderful memory alive through the hard work and spirit of Elma High School graduates.

Jeannette Effie DeYoung Mowe, 1925-2002, was the eldest child of Helen Fuller, whose family settled Fuller Hill in Satsop in 1883, and Sam DeYoung (born Sitze de Jong), a dutch immigrant dairy hand. A child of the Great Depression, Jeannette moved with the family in search of work and experienced brief periods of homelessness, ultimately settling on River Road outside Elma in 1939. Her father, Sam DeYoung, later founded a successful logging company and other businesses in Grays Harbor County.

Jeannette studied while working on the family dairy by posting French verb conjugations and periodic elements on the the milk house wall. She graduated as valedictorian of the Elma High School class of 1942 at the age of 16. She attended Washington State College (now WSU) for one year, majoring in zoology and making the Dean's List. Love and war intervened. She married Robert Mowe in 1943, and never returned to college.

This scholarship honors her sacrifice and intelligence. She raised four children as a logger's wife in a shotgun house at the end of Hurd Road in Hunters Prairie. She grew enormous gardens, canned food, picked wild blackberries, and supplemented the family income as a telephone operator, bank teller and secretary. At the end of her working career, she was the branch manager of the newly reopened Harbor Security Bank in Oakville.

She seldom spoke of her lost college opportunity. But there was never any doubt that her four children would graduate from college, and they all did.

"Our mother was the brains of the outfit. She graduated as Valedictorian of the Elma High School Class of 1942, made Dean's List at Washington State College the following year, then married and never had a chance to finish college. We were poor like most everyone else in Hunters Prairie in the 1950's and 1960's. Mom supplemented the family income by working as a telephone operator, bank teller, secretary, and (at the end of her career) as manager of the Oakville Harbor Security Bank. She made sure that we all took piano lessons, went to church, and studied hard. All four of her children have advanced degrees and have had successful lives. We owe it to her. Just as important, we recognize that talent and intelligence are as abundant in Grays Harbor as anywhere, even though resources may not be. We have funded this scholarship in our mother's name in the hope that it will provide a springboard for a young woman of promise. We were delighted to find the Foundation as a vehicle for this purpose. It provides the flexibility we need to combine endowment contributions and immediate distribution. The Foundation also has done an excellent job in publicizing the scholarship and selecting a winner. We look forward to years of partnership." Gregory Mowe- son of Jeannette

Agency Endowment Program Polson Museum

Last year, the Foundation launched an Agency Endowment Matching Program as a way to support nonprofit organizations in building endowments.

Agency Endowment funds are opened and held at the Grays Harbor Community Foundation by nonprofit organizations who wish to establish a fund that is kept in perpetuity to provide an ongoing stream of revenue generated by the investment of principal. Agency Endowments can also be established by donors who wish to specify a particular charitable agency or organization to receive proceeds from their fund.

As an extra bonus, the Foundation will match 20% of any new gift to an eligible agency endowment that has agreed to comply with our spending policy. Donations are subject to a maximum of \$10,000 in matching funds for each endowed agency fund per calendar year.

The Foundation was excited when we were approached by John Larson, Executive Director of the Polson Museum about starting an agency endowment fund. The Polson Museum has been beloved in our community since 1976 when it was gifted to the City of Hoquiam and Grays Harbor by the Arnold Polson Family.

Every year, Grays Harbor citizens and those just traveling through, are able to enjoy a part of the rich history of our community thanks to John and his incredible board and supporters. John said of the partnership with the Foundation, "Though the Polson has for many years self-managed an endowment, establishing a new and separate agency endowment fund at the Community Foundation was an easy choice. The Community Foundation's staff and board take an active roll in promoting new gifts to their agency endowments and the matching component gave an immediate boost to the principal. We look forward watching the fund grow through new gifts, investment growth and future GHCF matching dollars.

Stable long-term financial support is evermore crucial to organizations like ours and the GHCF's proactive approach to building endowments is commendable. At its core, the Polson is committed to preserving the Harbor's history forever. Likewise, the GHCF is committed to strengthening the Harbor's future forever – our mutual partnership was a natural fit in every regard."

Fun Facts

Prior to 1994, no Community Foundation existed in Grays Harbor County. If a donor wanted to leave their estate for the general benefit of our local community, they would have to establish a separate private Foundation or contribute to an organization with a narrower focus.

The GHCF began in October 1993 with a \$1,000 bank deposit contributed by Frank Larner. A Nonprofit 501(c) (3) Determination Letter was received in March 1994. Today we manage over \$66M in assets.
